B. Consider Approval of a Resolution Authorizing the Chief Executive Officer to Enter into a Contract with Stella Jones Corporation for As-Needed Bridge Timber Wood Treatment Services, for a Period of One Year, with Two One-Year Renewal Options, at a Cost Not-to-Exceed \$2,100,000 for the Full Contract Term.

C. Consider Approval of a Resolution Authorizing the Chief Executive Officer to Enter into a Contract with Cedar AI, Inc. for Cedar AI Rail Management System and Related Applications, for a Period of Thirty-Six Months, at a Cost Not-to-Exceed \$1,974,370.95.

Mr. Wendel presented and recommended approval of a resolution. Commissioner Ferrer moved to approve the resolution and Commissioner Williams seconded. <u>MOTION</u> <u>CARRIED UNANIMOUSLY</u>

D. Consider Approval of a Resolution Authorizing the Chief Executive Officer to Revise the New Orleans Public Belt Railroad Commission for the Port of New Orleans' Freight Tariff 9000-B.

Mr. Wendel presented and recommended approval of a resolution. Commissioner Carter moved to approve the resolution and Commissioner Ferrer seconded. <u>MOTION</u> <u>CARRIED UNANIMOUSLY</u>
